2017 Treat Yo' Self Raffle
Official Rules

These Official Rules apply to the 2017 Treat Yo' Self Raffle (Raffle) sponsored by Athens Canine Rescue (ACR) beginning August 28, 2017 and ending September 8, 2017, when the owner of the drawn Raffle ticket (Winner) for the prize package (Prize) is determined. Proceeds from the Raffle shall go to Athens Canine Rescue for its sole benefit and use.

Eligibility: Raffle tickets may be purchased by any persons who are at least 18 years of age or older.

Odds of Winning: Odds of winning depend on the number of eligible tickets sold. If 1,000 tickets are sold, the chance of winning is 1 in 1,000.

Selection and Notification of Winner: The Prize will be awarded through one random drawing (Drawing) from qualifying Raffle ticket stubs. The Drawing to select one will be conducted on September 9, 2017 by an ACR designated representative, whose decisions concerning all matters related to this Raffle shall be final. The Winner will be announced at the time of the Drawing. In the event of a dispute over the owner or holder of a Raffle ticket stub, the owner of the "winning" entry will be determined by the name and information provided at the time of purchase.

If the Winner cannot be reached within three (3) days from the first notification attempt, then such person may be disqualified and an alternate Winner selected through a Drawing from the remaining entries.

How to Participate: By participating in this Raffle, the contestant acknowledges that he/she is aware and agrees with the Raffle official rules. The price is \$10 per ticket, \$25 for three(3) tickets, \$50 for seven (7) tickets, \$75 for eleven (11) tickets, or \$100 for fifteen (15) tickets. Tickets may be purchased by cash, credit card, or check made payable to Athens Canine Rescue and are available for sale: (i) online at www.athenscaninerescue.com, (ii) from members of the ACR board of directors, or (iii) mailing check or cash to PO Box 7064, Athens, Georgia 30604. Online purchases made through the ACR website will be provided a confirmation page to acknowledge purchase. The contact information provided online will be used to generate a physical Raffle ticket. The participant will receive an email stating the numbers of the physical tickets they purchased. It is the purchaser's responsibility to provide a valid, deliverable email address and phone number to ACR. Online purchases will not be accepted after 12:00 pm September 8,, 2017. If an entrant's check or credit card is dishonored by the bank or credit card company, the Raffle ticket(s) will be invalid, voided and not placed in the Drawing and the purchaser will be notified. All Raffle ticket sales are final. Multiple entries are allowed, but only one entry per Raffle ticket. Raffle tickets are subject to availability, while supplies last.
